

CAMP LA-NO-CHE COVID-19 SAFETY EXPECTATIONS FOR CAMPERS AND STAFF

In accordance with CDC guidelines we have enhanced sanitation procedures and implemented additional measures for distance spacing and screening.

We ask that all campers, volunteers, and staff continue to comply with the following:



Masks/Face Covers are required while indoors, when directed by Staff, and/or if 6-feet of distance cannot be maintained.

Campers and Staff are asked to observe physical distancing, keeping 6-feet of distance between each other as much as possible. Where present, stand/sit on floor/seat markers.



Wash your hands with soap and water often, for at least 20 seconds. Hand washing is especially important before/after meals, after using the restroom, and after program.

Use hand sanitizer as an added precaution and/or when directed by Staff.



Please note the CDC advises that **older adults and people of any age who have serious underlying medical conditions might be at higher risk for severe illness from COVID-19.** Campers should evaluate their risk in determining whether to attend. People who show no symptoms can spread COVID-19 if they are infected, any interaction with the general public poses an elevated risk of being exposed to COVID-19, and we cannot guarantee that you will not be exposed during your visit.

Above policies/recommendations developed using up-to-date guidance by the CDC and modeled after accepted practices used at recreation locations in FL.

CAMPER EXPECTATIONS:

Masks:

- Campers (youth and adults) must have an appropriate mask/face cover on their person at all times.
- Campers (youth and adults) are expected to wear their mask/face cover when indoors, including but not limited to:
 - Dining Hall, including on Dining Hall porch, except while seated at a dining table to eat.
 - Trading Post
 - Ecology Lodge
 - STEM/Leadership Indoor Classes
 - Skills Building
 - Native American Indoor Classes
- Campers (youth and adults) are expected to wear their mask/face cover in outdoor environments where a distance of 6-feet cannot be maintained between others and/or when requested by Staff.
- Campers (youth and adults) should wash their masks with a frequency that ensures a clean mask for each day. Each Campers (youth and adults) will be given 2 masks for their use.

Hand Washing:

- Campers (youth and adults) MUST wash their hands with soap and water regularly throughout the day; it is essential that all campers wash their hands after using the restroom, before and after meals, and regularly throughout program times.
- Having a personal supply of soap and/or hand sanitizer is highly recommended.

Daily Cleaning:

All Units must clean/sanitize each day according to the expectations below:

- Twice daily, tables/surfaces should be cleaned according to the following process:
 - Spray all tables/benches/surfaces in Activity Shelter and bathrooms with provided cleaner.
 - Leave the cleaner for 5+ minutes.
 - After 5 minutes, rinse/wipe with clean water.
- Unit equipment that is shared by campers should also be cleaned/sanitized regularly.

Housing:

- Your Troop/Crew have been assigned to a campsite. This is YOUR living area; campers from other Units should NOT be in your site.
- Scouts should camp ONE PERSON PER TENT unless they are same-gender siblings. Adults using rooms in the activity shelter should camp TWO PEOPLE PER ROOM.

Program Areas:

- You and your Troop/Crew have been assigned a letter/color; this represents your "Cohort Group" which is your living, working community for the week. Program and meal rotations are managed by this letter/color.
- The daily schedule has been structured to minimize daily contact between staff/campers from group to group. You must follow your letter/color Cohort for day and evening programs.
- When breaks are scheduled, Staff and campers will limit travel to bathrooms and water/handwashing stations.
